**ORANGE DEMOCRATIC MOVEMENT
CODE OF CONDUCT**

I -----, an aspiring candidate for -----in -----
constituency -----County do hereby subscribed to the Orange Democratic
Movement Code of Conduct and solemnly declare that –

1. I shall observe this code of conduct pursuant to Articles 91, 92 of the Constitution of the Republic of Kenya, the Political Parties Act and the Party Constitution, Party Election and Nomination Rules;
2. I will at all times abide with this code of conduct so as to promote good governance, preserve and protect the good image of the party;
3. I pledge my loyalty to the Orange Democratic Movement;
4. I shall promote policy alternatives responding to the interests, the concerns and the needs of the party members;
5. I shall respect, cooperate and uphold the democratic rights of other members in competition for political power so as to implement their policies;
6. I shall respect the promotion of consensus building in policy decision making on issues of national importance that affect the party;
7. I shall respect the right of all persons to participate in the political process including the youth, minorities and marginalized groups;
8. I shall respect and promote gender equity and equality, human rights and fundamental freedoms;
9. I will at all times be tolerant and inclusive in all my political activities.
10. I will at all times respect, uphold and defend the Constitution of the Republic of Kenya;

11. I shall respect and uphold any other written law relating to elections and political parties;
12. I shall respect, uphold and defend the party constitutions, party election and nomination rules, manifesto and any other party rules and regulations developed and agreed upon in accordance with this code of conduct;
13. I shall respect, uphold and promote human dignity, equity, social justice, inclusiveness and non-discrimination and protection of the marginalized;
14. I shall respect, uphold and promote human rights and the rule of law;
15. I shall at all times promote national patriotism and national unity;
16. I shall respect, uphold and promote democratic values and principles, performing inclusive the participation of party members and accountable representation in governance for the development of Kenya;
17. I shall respect, uphold and promote good governance, integrity, respect, tolerance, transparency and accountability;
18. I shall respect all party organs and the Party leadership;
19. I shall uphold and promote the principle of regular free, fair and credible elections within the party organs;
20. I shall respect, uphold and promote the principle of leadership and integrity as enshrined in the constitution of the Republic of Kenya;
21. I further commit to:
 - a. at all times use constructive dialogue to manage and mitigate political differences;
 - b. promote national reconciliation and building national unity;
 - c. take all reasonable steps to protect election officers in their course of duty;
 - d. take necessary and reasonable steps to instill discipline in Party candidate representatives, employers, supporters;
 - e. make monthly contributions towards the financing of party operations once elected
22. I further aver that I shall not –
 - a. engage in or encourage violence by party members or supporters;
 - b. engage in or encourage any kind of intimidation of opponents, any other person or any other political party;
 - c. engage in influence peddling, bribery or any other form of corruption;

- d. accept or use illicit or illegal money;
- e. accept or use public resources other than those allocated to the political party through the political party fund;
- f. advocate hatred that constitutes ethnic incitement, vilification of others or incitement to cause harm;
- g. obstruct, disrupt, break-up or in any other way whatsoever interfere with a meeting, rally or demonstration of another political party or its leadership;
- h. establish or maintain a Para-military force, militia or similar organization or having any links with such organizations;
- i. use state resources for partisan campaigns;

- j. establish or maintain a Para-military force, militia or similar organization or having any links with such organizations; and
- k. engage in violence, intimidation in language or action that might lead to violence or intimidation;
- l. allow weapons to be carried at political meetings, voting stations, etc.
- m. publish or report false, defamatory or inflammatory allegations about political opponents;
- n. prevent eligible voters from having access to political opponents;
- o. bribe eligible voters;
- p. abuse positions of power or privilege;
- q. discriminate on the basis of race, sex, ethnicity, social class or religion.

23. Loyalty to the Party.

Advocate and defend Party values and aspirations as set out in the Party constitution

24. Demonstrate positive and dynamic leadership that translate the party policy and programmes into action and impact.

I shall undertake to;

1. Adhere to the party programmes and policies for the entire duration that I shall be a member of the party;
2. Respect party organs and institutions of the party democratization practices;
3. Promote the practice of intellectual honesty in all dealings;
4. Articulate civility in terms of language, tolerance and expression;
5. Promote mutual respect to members at all levels;
6. Respect institutions of decisions-making to avoid sycophancy and patronage;
7. Be committed to faith and God;
8. Appreciate and acknowledge the strength of Kenya's cultural diversity;
9. Mitigate negative cultural norms;
10. Promote gender equity at all levels of governance;

11. Advocate for non-violence of any kind;
12. Show patriotism to the state;
13. Promote affirmative action;
14. Ensure equitable distribution of resources;
15. Promote and respect citizens' rights.

Any member who evidently defaults on the above shall be subject to:-

1. Suspension from the Party.
2. Denial by Orange Democratic Movement of its ticket for candidature.
3. Denial of Orange Democratic movement elective leadership.

4. If the default borders on criminal offence, the party shall hand over the case to the state.
