RE: PARTY GRASSROOTS ELECTIONS

The National Elections Coordinating Committee (NECC) is mandated under Article 61 of the Party Constitution *“to plan, organize, direct, conduct, supervise and/or co-ordinate all party elections and nominations of candidates”* which includes the party grassroots elections.

Following the Notice issued on 4th November 2024 regarding the above subject, the NECC wishes to announce the following:

1. **That** in collaboration with the Party’s Legal Committee, the NECC conducted training and officially appointed the County Elections Committees (CECs) for all the forty-seven (47) Counties.
2. **That** only the Polling Unit elections will be conducted on the 27th November 2024 in all Gazetted Polling Centres across the country.
3. During the elections, Party members will elect a total of thirty officials being as follows:
 - a) Ten officials of the Polling Unit Steering Committee;
 - b) Ten officials of the Polling Unit Women League; and
 - c) Ten officials of the Polling Unit Youth League.
4. **That** in order to facilitate the preparation of the voter register, the ongoing registration of members will temporarily be **suspended on Wednesday 20th November 2024**.
5. **That** Party supporters and members are encouraged to use the remaining days to register and verify their membership details by dialing *483*036# or visit www.odmmembership.com.
6. **That** members eligible to vote and vie for positions will undergo electronic verification at their respective polling units/centres.
7. **That** Party members are requested to avail themselves in their respective polling units/centers on Monday 25th November 2024 at 10 am for the purpose of electing Presiding Officer, who will oversee the elections scheduled for 27th November 2024.
8. **That** in accordance with the Party Election & Nomination Rules, members who are interested in contesting for the stated Polling Unit Official positions shall pay a non-refundable fee of Kshs. 100/= to the Presiding Officer on the morning of 27th November 2024, before 10:00 a.m., upon which a receipt will be issued.

9. **That** any candidate aggrieved by the election results may appeal by lodging a complaint in the prescribed format and paying a fee of kshs. 3,000/= within 24 hours after the declaration of the results. The fees must be paid via the **Party's Paybill No. 985900; Account: Appeals Fee.**
10. **That** members are encouraged to read and acquaint themselves with the guidelines for grassroots elections. The Party Elections and Nominations Rules, 2021, can be downloaded from the Party website www.odm.co.ke.
